church. His petition, included in the packet for the meeting, argued the property was eligible for annexation because:

- More than 1/6th of the perimeter is contiguous to the town.
- There is a community of interest with the town.
- The land is rural and capable of being integrated with the town.
- The annexation will not change any school dis-
- The land will not be divided without the consent of the owner.

Scott Krob, the town attorney, said the annexation process has three steps:

- Filing a petition with a map, which has been done.
- A determination of eligibility.
- The annexation itself,

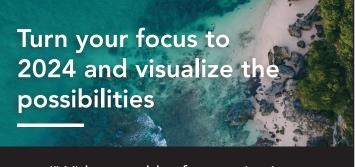
