roadway, the Mission Hill Way cul-de-sac. The development would add 22 more single-family-home lots, only accessible via Mission Hill Way, which already serves two townhome developments and multiple single-family lots. The second request, supported by Donala, was to allow for a water sufficiency finding for a 100-year water supply as required by the state instead of the county's required 300-year water supply.

Specifically, two proposed private detention ponds would drain through a proposed surface outfall ditch between two existing single-family homes at separate locations along Westchester Drive, and there is currently no drainage easement between the lots.


