The Rabbi's Corner What Do You Say?

Dear Reader, this month's article will be somewhat different from my writings you have been used to reading every month. Normally, I cover a subject looking at it from a theological perspective. In this month's article, I want to describe to you an experience I had just a few weeks ago. In a nearby city here in Colorado, there was a birthday celebration for a long-term friend, who is a committed believer and practices the Christian faith with all sincerity. So, for his birthday celebration he invited some brothers and sisters from his church, his Pastor and me. Since we have been friends for many years, his Pastor and I have had a good friendship with mutual admiration and respect for each other's ministry, although we have different views about many issues, and theological positions, we both practice from our hearts Romans 15:7 "Receive those whom the Lord has received." And we both do this with great joy.

Normally, we never get into discussions about theological issues, but on this occasion we were talking and he asked me: "What do you say about the Trinity?" My response was an honest and straightforward one: "I don't believe in it. It is not found in the Bible. It is man-made doctrine". My dear brother asked me: "But what about his baptism?" My response was, "You mean the fact the Lord was in the water, that there was a symbol for the Spirit as a dove, and a voice from heaven, saying 'This is my beloved son in whom I am well pleased'? Is this the proof for the doctrine of the Trinity that you have?" His response was a strong "Yes". So, I mentioned to my dear brother, that one of the attributes of our God is the fact, that he is "Omnipresent" (meaning that God has the ability to be everywhere at the same time). I then went a step further, stating "If it is truth that God is Omnipresent, then he doesn't need to be three persons to be present in three places at the same time." He wholeheartedly agreed with this statement. I concluded my discussion by mentioning to my dear friend the five articles recently published in OCN, about The Most Important Commandment and the text in Mark 12:28-35, where the Lord Jesus Christ said "God in One". I asked him: "Brother, the Lord Jesus Christ has said 'God is One'. Now, What Do You Say?" He didn't respond to my question.

This is the same question I will leave you with; after reading Jesus' own words would you want to offer your opinion on His description of Himself. Or would you be so bold as to disagree with His description, assuming He is misinformed about how He is formed, so that you can continue to believe He is three in one? Another choice may be for you to do, what I did many years ago—abandon the Holy Trinity invention that was made by the Nicean Council and embrace wholeheartedly the teaching of the Lord Jesus Christ that "GOD IS ONE". Please allow me to convey to you the importance of this clear realization between you and your God. I'll be praying that he will direct you in respect to this issue; be sure that a prayer will be made for you as my reader.
