The board also voted to accept several changes to the district's portion of the 2015 budget for the JUA, with Director Jim Taylor abstaining. Director Rich Strom recommended accepting several

changes, which include an expectation of reduction in costs associated with not hiring another employee at the wastewater treatment plant, not purchasing a pickup truck, and delaying the decision to build a shed in 2015. According to District Manager Jessie Shaffer, the district had already included these costs in its 2015 budget for the wastewater plant prior to the board's recent decision to accept the reductions. Shaffer said the implication of the phosphorus removal construction project will not be noted (in Revision 5 amendments to the JUC budget) as construction by thirds. The board voted 3-0 in favor with director Jim Taylor abstaining.

Secretary Beth Courrau chaired the meeting in lieu of Director Barrie Town's absence. Treasurer Tommy Schwab and Directors Jim Taylor and Rich Strom were present. Also at the meeting was district resident Russ Broshous, who asked the board what WWSD would be charging

for tap fees and other services for undeveloped lots. Shaffer gave Broshous a copy of the rates.


